The news on the National AUSSI scene can only be described as exciting and incredibly busy. On September 21st and 22nd, 14 delegates, representing the 7 Branches of AUSSI met at Cronulla N.S.W and together with the National Executive, clocked up approximately 16 hours of meeting time in two very full days.

Some interesting aspects to come out of the meeting included:

The adoption of our draft Rules

These have been see-sawing back and forth for many moons, however the amount of 'man' hours spent on them by clubs, Branches and various committees is an indication that our final document should be worthwhile.

In the next few months we hope to give each club secretary a hardcover booklet containing the National Constitution; By-Laws and our Rules. The pages will be loose-leaf and therefore easier to keep updated.

Interpretation of the Rules for Referees remains a difficult area and was discussed in full at the National Council meeting. It has been referred to the National Technical Committee for policy recommendations and from the general concensus reached, I feel we will go a long way to solving our problems in this area.

Fees

The Council resolved that Branch affiliation and registration fees for National would remain unchanged for 1986. The National Executive further moved that any member registering for the 1st time after October 1st in a year, need only pay \$5 National registration instead of \$7.50.



This pro rata fee for initial registrations was to assist those new members who could be asked for two lots of fees in a short space of time.

It might be appropriate here to reaffirm AUSSI policy that clubs are required to register <u>ALL</u> of their members. There is no form of social membership within AUSSI. Any person, 20 years and older belonging to an AUSSI club is required to be registered.

Some ill informed sources once felt that you only needed to register if you wished to join in the competitive swims. This is not so. The constitutional objective of AUSSI is to encourage all adults, regardless of age or ability, to swim for fitness and health. Clubs provide all types of incentives, both swimming and social to fulfil this major objective and keep-people swimming and interested. If a club does not register all their members it raises three main areas of concern:

- It is illegal according to AUSSI Rules
- It poses problems with insurance and liability coverage
- 3. It is unfair to those registered members who have to carry the financial burden for others who swim regularly.

National Director of Fitness & Coaching

Many of you will be sad to hear of the resignation of your National Director of Fitness & Coaching, Des McCormick. Des is an easily recognised Marshall at many swims. His position has been filled by another well known coach in AUSSI - Dick Campion of Victoria. We wish Dick all the best in his new role, (and hope he doesn't work us too hard.)

Affiliation with Australian Swimming Incorporated.

One of the few unanimous decisions of the National Council was that AUSSI should make application to affiliate with Australian Swimming Incorporated (the new name for the A.S.U). This has followed on since F.I.N.A and Masters Swimming International reached their agreement, and should be of benefit to AUSSI swimmers, especially those who wish to continue swimming with amateur clubs.

Those who are in the 20-24 year age group will still not be covered, but AUSSI members over 25 who are not considered professional, may shortly be able to participate in both Australia Swimming Incorporated and AUSSI events.


Insurance and legal liability

As can be seen by the memo sent to clubs recently, AUSSI will be making Personal Accident coverage for clubs mandatory from January 1st 1986. This together with our already mandatory Public Liability coverage of \$2 million dollars should go a long way to protect AUSSI members.

Club executives and committees are further advised that National has a Personal Accident policy which also covers you carrying out your club responsibilities.

We can all be justly concerned with the possibility of legal litigation. However, i we are seen to be taking every precaution

and seek adequate coverage where possible, I don't think club committees need to have too many sleepless nights. I hope we never get to the stage where all the paperwork and insurance headaches make us feel like our friend below:
